The following is a report on the examinations performed on the above captioned patient at the BRICK office.

MRI EXAMINATION OF THE LUMBAR SPINE

HISTORY:

Low back pain and lumbar radiculopathy.

Sagittal and axial imaging was acquired on a 1.5 Tesla scanner without contrast enhancement.

The lumbar discs are normally hydrated for age. There is a small central disc protrusion at L3-L4 minimally effacing the thecal sac. There is mild spondylosis most marked at the left paracentral region at L5-S1 which does not appear to compromise the downgoing S1 nerve root or thecal sac.

The other lumbar discs are without significant abnormality. There is no central or foraminal stenosis. No significant facet arthrosis is seen. There is no evidence of a vertebral body fracture or metastasis. No intrinsic intrathecal abnormalities are seen.

IMPRESSION:

SMALL DISC HERNIATION AT L3-L4. MILD SPONDYLOSIS AT L5-S1.
